


**NORFOLK COUNTY COUNCIL (THETFORD)**  
**TEMPORARY TRAFFIC RESTRICTION ORDER 2020**  
**ROAD TRAFFIC REGULATION ACT, 1984 SECTION 14(1)**

ORDER restricting the use by vehicles of the B1107 Brandon Road from its junction with the A11 for a distance of 2750 metres north westwards (the County Boundary) in the TOWN OF THETFORD

1. Whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that surfacing works are required at the B1107 Brandon Road from its junction with the A11 for a distance of 2750 metres north westwards (the County Boundary) in the TOWN OF THETFORD (hereinafter referred to as the said road) and that in consequence, traffic over the said road should be restricted on the following dates and times:-
  - (i) with effect from 20:00 hours on 15<sup>th</sup> June 2020 to 18:00 hours on 5<sup>th</sup> July 2020 the road will be subject to the imposition of a 30.mph speed restriction for the duration of the works; and
  - (ii) traffic over the said road should be prohibited as follows:-
    - a. between 20:00 and 06:00 hours from 15<sup>th</sup> July 2020 to 18<sup>th</sup> July 2020;
    - b. between 05:00 and 18:00 hours on 28<sup>th</sup> June 2020; and
    - c. between 05:00 and 18:00 hours on 5<sup>th</sup> July 2020.
2. This Order has a maximum duration of 18 months and will be revoked upon completion of the works. Where exceptional circumstances are encountered during the performance of the works specified in this Order the operational period of this Order may become extended to allow completion of the works after obtaining consent of the Secretary of State.
3. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.

NOW THEREFORE the Norfolk County Council DO HEREBY ORDER, that with effect from 15<sup>th</sup> June 2020 to 5<sup>th</sup> July 2020 for the duration of the works the said road SHALL BE SUBJECT to the imposition of a 30mph Speed Restriction and that with effect between 05:00 and 18:00 hours on 28<sup>th</sup> June 2020 and 5<sup>th</sup> July 2020; and between 20:00 and 06:00 hours from 15<sup>th</sup> July 2020 to 18<sup>th</sup> July 2020 for the duration of the works the said road SHALL NOT BE USED by any class of vehicle. .
