Supporter: Thetford Town Council supports this application, with the following provisos:

- We would welcome the installation of litter bins on the walking routes approaching the site.
- Signage for lorries indicating that they should turn right out of Caxton Way should be installed on site in addition to those already in situ outside on the road.
- Given the site's proximity to parts of Maine St, Mackenzie Road and St Martin's Way, Breckland Environmental Officers' judgements over noise levels must be given due consideration to ensure that residents in those areas do not suffer disturbance.
- The fencing facing St John's Way should be painted green in order to lessen the site's visual impact.

	<ul style="list-style-type: none"> • For the same reason, the rear elevation of the building should also be of a less bright colour. • Cycle provision must be implemented and monitored to ensure that it remains adequate. <p><u>G: Plan No 0095</u></p> <p><u>Consultation on Planning Application which will be determined by Suffolk County Council</u></p> <p>Extraction of sand and gravel and subsequent importation of inert waste material to achieve a beneficial restoration of the site back to heathland on land at North Farm, Barnham. Location: North Farm, Elveden Road Barnham Thetford IP24 2PH. The above application will be determined by Suffolk County Council.</p> <p>The Planning Officer introduced this item by saying we are only a consultee to the Suffolk County Council and that he was alerted to this application by the Clerk of Barnham Parish Council. This application would send three or four full HGV vehicles an hour, up to forty heavy loads a day, through Thetford on the Bury Road.</p> <p>Committee members commented on the application:</p> <ul style="list-style-type: none"> • This application is very concerning for the Town of Thetford – There have been decade long issues with HGV traffic going through town damaging our roads and being a danger to pedestrians. This project will last 5 years and we must write to NCC to have HGV Restrictions covering the whole of Thetford. • There will be too much pressure, and damage on the roads with more broken drain covers and damaged kerbs. • This traffic could come off the A11 past the Gorse industrial estate missing the town altogether. • The amount of HGV traffic in the town now is already more than it can cope with. <p>It was decided:</p> <ul style="list-style-type: none"> • To write to Suffolk County Council to strongly object to this application. • To write to Norfolk County Council and Breckland District Council to ask them to support the Councils objections to this application. • To write to NCC to impose a HGV restriction on the Bury Road (A134). • Publicise this planning application on Social media with a link to the Suffolk CC planning application so the residents of Thetford can express their views on this proposal.

He had circulated a paper which governed the naming of street names and there followed a discussion. Councillors were in favour of compiling a bank of names and this item will be put on the agenda from time to time for this purpose.</p>
783/20	<p><u>BIKE RACKS</u></p> <p>The Chair reported Breckland District Council are proposing to install bike racks on Castle Park. They had sent a photograph of the proposed site and had asked the council to agree the placement. It had been pointed out that as Castle Park was an Ancient Monument this location would not be allowed. After a discussion it was proposed they should be placed further right behind the toilets which was outside the bounds of Castle Park.</p>
