749/23 UPDATE ON THE KINGSFLEET SUSTAINABLE URBAN EXTENSION (SUE)

The representatives from Pigeon gave an update on the Kingsfleet SUE and answered questions from Councillors covering: -

- The timing of development.
- The latest update on the provision of schools.
- Streetlighting.
- Allotments.
- Playparks.
- Medical centres and facilities.
- Provision of recreational activities.
- Social and affordable housing.
- The retail offering.
- Additional access to Norwich Road.

In addition, there were some concerns raised about the laying of additional cabling to the Kingsfleet SUE through other parts of the town and the damage that had been done.

It was agreed that the Councillors should be provided additional information on the Section 106 agreement, particularly the trigger points.

The update was noted.

As the meeting had been in progress for 2 hours, it was agreed to suspend Standing Order 3x.

750/23 GUILDHALL TWO TOWERS UPDATE

The Councillors discussed an update on the Guildhall Two Towers, which was circulated prior to the meeting:

- A significant cost of £70, 000.00 has already been spent on scaffolding for The Guildhall.
- Two professional companies were engaged to assess the two towers issue.
- A Project Manager should have been appointed to look after Council properties.
- The Guildhall needs to be maintained for the residents of Thetford.

After a discussion, it was decided to proceed with Option Two:

Councillor Terry Jermy proposed, and Councillor David Blackbourn seconded.

RESOLVED: That the Clock Tower to be repaired now and the scaffolding to then be removed, which will incur another £6,000.00 - £8,000.00 of scaffolding rental costs.

The Committee agreed to change its procedures relating to the filming of the public forum that takes place before the Full Council meeting.

It was agreed that the Council will film and allow the public to film the public open forum on the basis that a separate area would be set aside for those not wanting to be filmed. The Council will issue a statement setting out the new processes. The Council will put an encourage residents to submit questions in writing for the public open forum and answering these will be given preference.

Councillor Matthew Stirrup proposed, and Councillor Terry Land seconded.

RESOLVED: That these procedures for recording the public open forum be adopted.
