591/23 DECISIONS OF VARIANCE

Applicant: Unit 3 at the Breckland Retail Park, Caxton Way, IP24 3RZ. Planning application 3PL/2023/1144/VAR The Council had objected to the Variation of Condition 12 to allow the Shoe Zone to occupy Unit 3 at the Breckland Retail Park.

Breckland Council gave permission for this Variation of Condition.

The decision of variance was noted.

Applicant: Breckland Leisure Centre Croxton Road, IP24 1JD.

The Council had supported this application but had requested two conditions. Condition One was to request baffles on the lights and a further assessment of the height and robustness of the backstop netting.

Condition Two was to move the development away from houses to make the pathway safer.

These were not included in the full permission to the plan by Breckland Council.

The decision of variance was noted.

Applicant to rear of 21-25 Guildhall Street IP24 2DT

Breckland Council had given full permission. The Council had objected to this development and were disappointed with the Decision of Variance. The following matters were discussed:

- The lack of knowledge of Thetford by officers and councillors making planning decisions at Breckland Council.
- There was an acknowledgement that planning training for Thetford Councillors and Officers was lacking and therefore planning objections were not being appropriately worded or articulated.
- There could be a need to attend Planning Committee meetings by Officers and Councillors.
- There was a perceived bias towards developers because Breckland have financial disincentives to reject develop planning applications.

It was requested that a letter be written to Breckland Council by the Mayor expressing the disappointment with some of the planning decisions made, including this planning application.
